1. You must be able to claim all children listed as dependents for IRS purposes.
2. Additional live-in adults include nannies and nondependent adult children who reside at the member's address. Other guests can enter the pool for a daily guest fee.
3. Adults or teens who volunteer at least two hours at any of our pre-season pool work parties (setup, cleaning, painting, planting, maintenance, etc.) will be given a \$10 Snack Bar credit per membership. See website for work party dates.
4. If you choose to rent, the \$100 fee can be applied to a bond purchased by 12/31/2019.
5. Please note that according to our by-laws, partial bond payments are non-refundable.
6. Paypal charges us approximately 3%, so we must add this fee for the convenience of paying by card or Paypal.
7. Resignations are due in writing and must be postmarked no later than April 1<sup>st</sup> of the year you resign to receive full reimbursement of bond. Reimbursements are queued in order of receipt and not guaranteed until purchased by a new member.
8. Current bond holders who have an outstanding balance when the pool opens will not receive pool privileges until the balance is paid in full.
9. All fees are non-refundable
10. There will be a bond forfeiture if maintenance fee is not paid by July 1<sup>st</sup>, 2019
